You will need an I-20 form if you are a full-time student during Summer School, that is if you are taking 6 units or more in either Summer Session I or II.

Bank statements must be original copies that reference the account holder's name. Originals will not be returned.

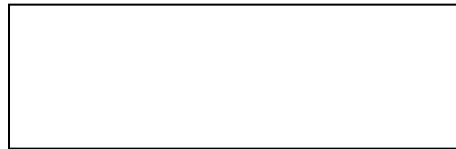
